Contributions to Perdue for Senate are not tax deductible as charitable contributions. Individuals may contribute up to \$2,800 per election and \$2,600 for 2014 general election debt retirement. By signing above as an individual, you agree to designate the first \$2,800 of your contribution to the 2020 primary, the next \$2,800 to the 2020 general election, the next \$2,800 to the general run-off election, and any remaining amount up to \$2,600 to retire 2014 general election debt. Federal multicandidate PACs may contribute up to \$5,000 per election. By signing above on behalf of a multicandidate PAC, you agree to designate the first \$5,000 of the PAC's contribution to the 2020 primary, the next \$5,000 to the 2020 general election, the next \$5,000 to the general run-off election, and any remaining amount up to \$5,000 to retire 2014 general election debt. Contributions from corporations, labor unions, federal contractors, and foreign nationals (non-green card holders) are prohibited. Contributions must be made from personal funds and may not be reimbursed by any other person. Federal law requires us to use our best efforts to obtain and report the name, mailing address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200 in an election cycle.
